Waiver of Liability: In consideration for participating in any way in the event, program or trip listed above, hereinafter "The Activity", I, for myself, my heirs, personal representative or assigns do hereby release, waive, discharge, and covenant not to sue NVATU, its officers, directors, and volunteers from any and all claims including the negligence of the NVATU, its officers, directors, and volunteers, resulting in personal injury, accident, illness, or death, and property loss arising from, but not limited to, participation in the activity.

THAT I AM IN GOOD PHYSICAL CONDITION AND CAPABLE OF MEETING THE PHYSICAL DEMANDS OF THE ACTIVITY, AND I KNOWINGLY ASSUME ALL SUCH RISKS.

Indemnification and Hold Harmless: I agree to indemnify and hold NVATU harmless from any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees brought as a result of my involvement in the Activity and to reimburse NVATU for any such expenses incurred.

SEVERABILITY: The undersigned further agrees that the foregoing waiver and assumption of risk agreement is intended to be as broad and inclusive as is permitted by the law of the Commonwealth of Virginia and that if any portion thereof is held invalid, that the balance shall continue in full legal force and effect.

Acknowledgement of Understanding: The participants have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing the agreement freely and voluntarily and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
